FDR (a) Grand Convention

At the July 19, 2023 Grand Convention, FDR's Corey Bearak delivered his Report as Chief Grand Tribune:

► Last year, as a follow up to guidance provided at that previous convention, on July 18, 2022, the tribunal issued a two-page advisory opinion. It followed an informal question presented on whether the Grand Law extends voting rights at a Grand Convention to a lodge operating on a warrant (as opposed to a lodge operating under a Charter. No formal opinion was sought. Since the state of Grand Law was announced as an opinion of the Grand Tribunal, the Grand Tribunal found it useful and practical to issue an advisory opinion that simply stated the fact that a lodge operating under a warrant "are entitled to representation in the Grand Lodge pursuant to the Grand Law."

- ▶ In addition, at the November 7, 2022 Grand Council meeting, I brought up under Good of the Order that it has come to my attention without explaining why, as not to prejudice any possible future matter properly brought before the Tribunal, that the current process for bringing matters before the Grand Tribunal involves service in person or by mail. I had explained then that I wanted to share this information in case anyone would want to propose a change in the existing law at the next, this Grand, Convention. This means existing Grand Law does not permit any service (of legal papers) by email in order to commence an action under Grand Law. Apparently, no one submitted any resolution proposing such a change in Grand Law at this convention. As I stated then (November 7, 2022) and still hold that same position today, I wish to make clear I have reached no (personal) opinion on any need to change or not change existing Grand Law, but since it involves legislation, and can be changed, it makes sense to bring that fact to the full body to consider today or thereafter.
- ▶ In efforts subsequent to the updating of the Grand Constitution and Statutes reported on at the last convention, I learned that a change in the Constitution needed to be submitted to Supreme Lodge for approval. As of the date I prepared this report, I have not learned of any approval and there could be retroactive impacts on some matters approved at prior Grand Conventions based on the applicability or inapplicability of the provision involved which governed voting and the votes of subordinate lodges.
- ► A number of matters in the last year that I found as potential violations of Pythian law potential only because I sought no rulings and brought no matters before my colleagues on the tribunal occurred. I made a judgment that it served no purpose to pursue a formal resolution as names and details would then need to be entered in the Journal of Proceedings; I prefer not to see my domain embarrassed in any way and prefer any such matters to go to a landfill to decompose. I shared with my associates on the tribunal my view and intentions and offered the opportunity to "overrule" me but no such response materialized. Subsequent matters occurred and I am still considering whether to change my prior response. I have a lot going on in my professional, personal and outside of the order voluntary commitments lives so that may delay me further as well in any further response.
- ▶ Finally, a recommendation. Events during the past Pythian year, perhaps a bit beforehand, identify a need to clarify the role of the Grand Advocate. Outside the order similar roles would by tradition, practicality and/or law proscribe that means bar or prohibit, the person whose role is to provide legal guidance and often prosecute and/or initiate and bring matters on behalf of for example, in the case of our order, the Grand Chancellor, Grand Council, or Grand Lodge, not to handle any private matter that would be adjudicated within the order. When the legal advisor represents a private party, that creates an inherent conflict of interest no matter how pure of heart and upstanding such legal advisor might be. If a legal advisor acts in such a manor that presents such a conflict and Grand Chancellor is unable or unwilling to require a legal advisor to avoid such conflict, or replace such legal advisor, the best solution would be to codify the proscription. Thus, I bring this to the attention of the body so it can act now or in the future.
