Bayview-Nemo Benevolent Assoc.

A deceased member in good standing and his spouse are each entitled to a grave in one of our cemeteries. The family receives \$750 for the member and \$500 for the spouse after the monument is erected or engraved. If the member or spouse was not buried in a Bayview-Nemo deeded property, the benefits will go to the family upon receipt of a death certificate. A widow remains in good standing by making a one-time payment of \$100.

Grave reservations are \$200 for a surviving spouse at the time of need. A couple can reserve a pair of graves in advance for \$400. The families of all internments pay a cemetery fee of \$50.
